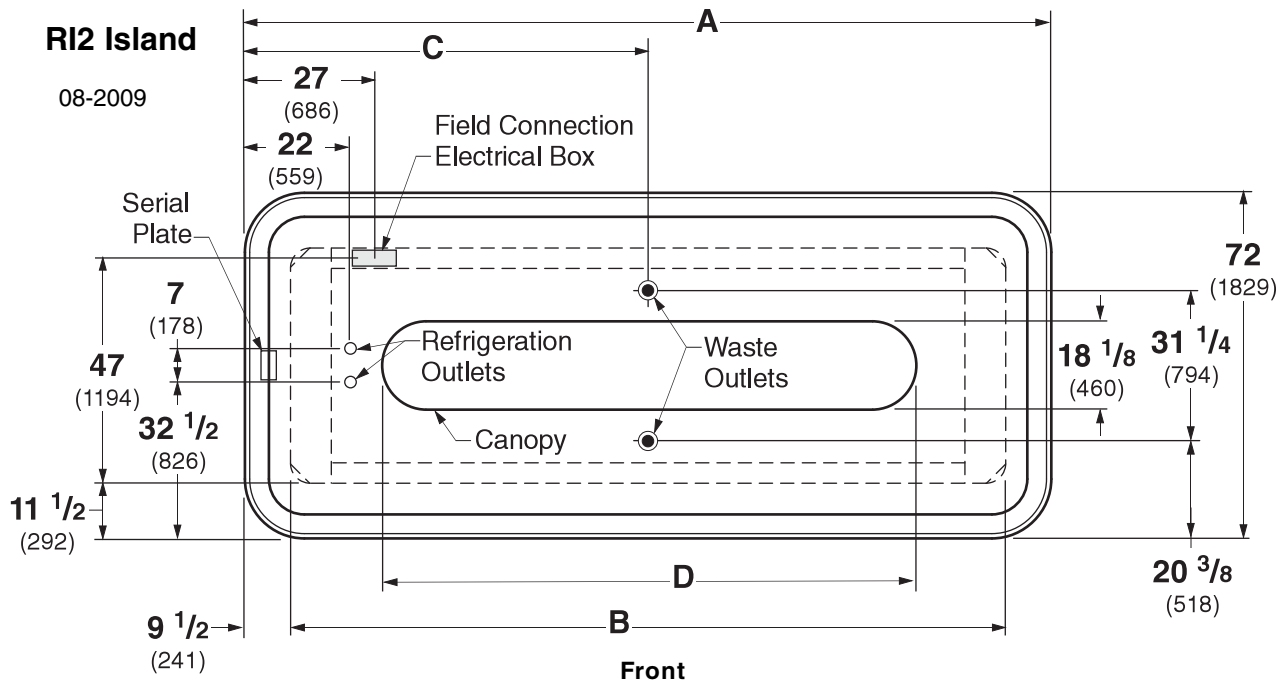

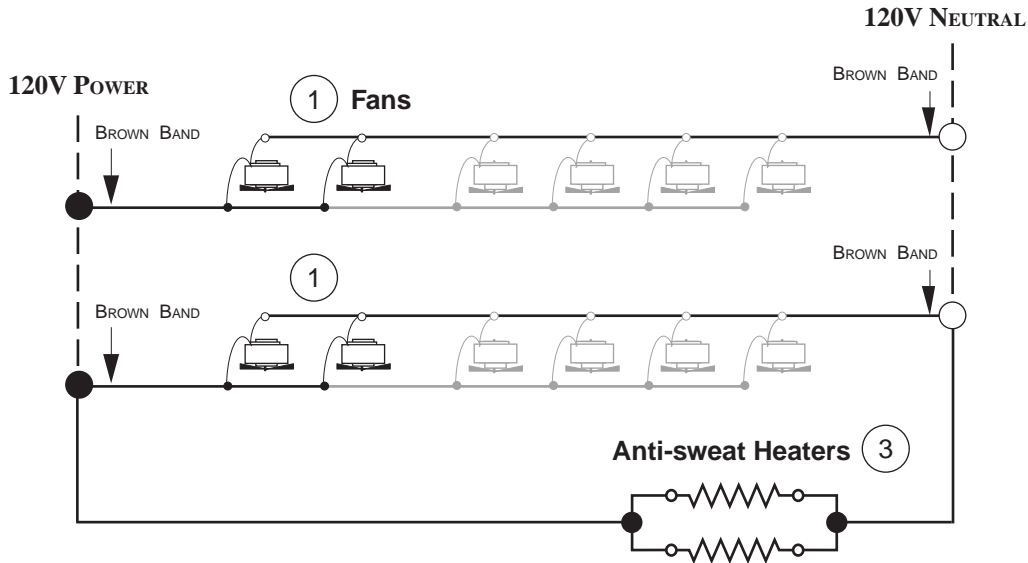

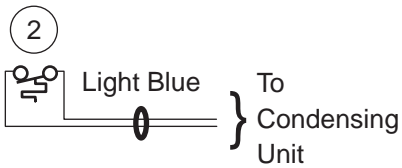

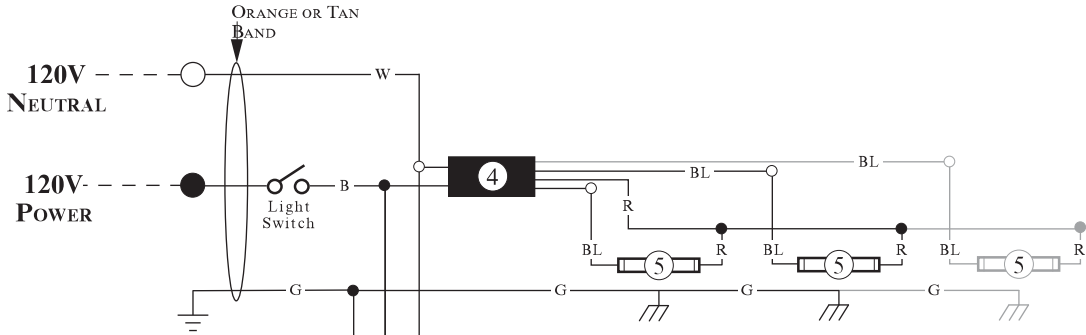

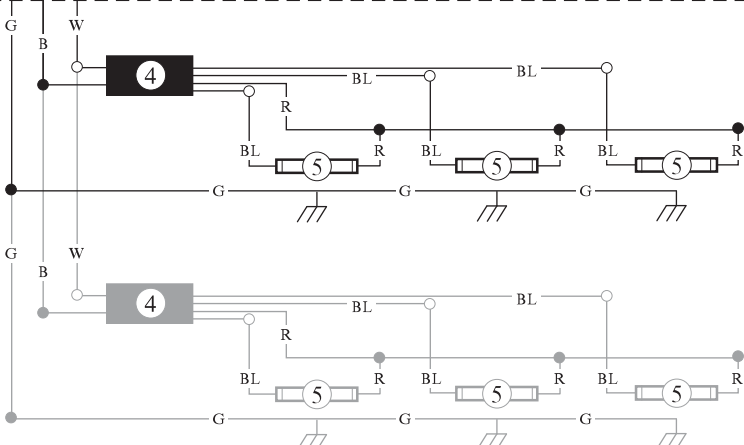

Standard Lighting — 1 Row Canopy

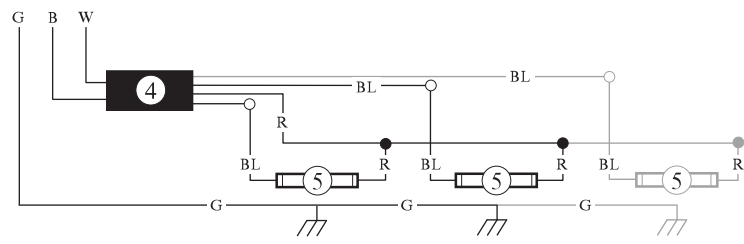


Lighted Shelf Wiring
