

## **Components Containing Limited Coverages beyond Standard OEM Equipment Warranty**

Hussmann warrants to the original purchaser the new equipment and all original parts to be free from defects in material and workmanship under normal use, maintenance, and service from date of shipment from factory. A new one-time replacement part will be provided without charge, provided the defective part is returned to Hussmann and deemed a true warranty failure. Any part determined not to be warrantable or not returned, will be charged to the account on file at the time the part order was placed.

Eco Vision Retrofit/Upgrade Kits	OEM components only (applicable to moisture penetration only)	Photos/video of entire door are required prior to warranty consideration for any parts orders and labor claims  **Glass breakage not covered	15
Sealed Multi Glass Door Assemblies: Eco Vision	OEM components only (applicable to moisture penetration only)	Photos/video of entire door are required prior to warranty consideration for any parts orders and labor claims  **Glass breakage not covered	60
Sealed Multi Glass Door Assemblies: Innovator Walk-In & Reach In	Shipped prior to 01/01/2009 (applicable to moisture penetration only)	Photos/video of entire door are required prior to warranty consideration for any parts orders and labor claims  **Glass breakage not covered	84
Sealed Multi Glass Door Assemblies: Innovator Walk-In & Reach In	Shipped after 01/01/2009 (applicable to moisture penetration only)	Photos/video of entire door are required prior to warranty consideration for any parts orders and labor claims  **Glass breakage not covered	120
Electronic Ballasts	In usage with Innovator Doors only (applicable to original OEM equipment orders only)	-	36
LED Fixture/Power Supply	OEM & Retrofits	Must meet guideline criteria (Refer to policy: LED lighting for New and Retrofit Cases)	See policy on www.husmann.com
Self-Contained Compressors	Applicable only on the models called out on the Self-Contained policies on the website	Must meet guideline criteria (Refer to Self-Contained Compressor Warranty for system Policy and Procedure)	See policy on www.husmann.com
